ProjectPengyou.org is an online community of Americans who have lived or studied in China. Conceived as the alumni network of President Obama's 100,000 Strong Initiative, ProjectPengyou.org is a prominent public-private partnership of the national initiative. ProjectPengyou.org seeks to mobilize alumni to become champions for Americans to study in China, and provide meaningful ways to stay engaged with China. This year, we launched features to compliment the alumni building efforts of the Hopkins Nanjing Center, including more developed alumni group features. We also organized a number of events to promote alumni engagement for HNC.  
Our goal moving forward is to build ProjectPengyou.org into an aggregator of online groups, people, jobs, events and resources related to China, and promote China engagement and study.

Project Pengyou grassroots engagement efforts - In 2013, we began to design offline grassroots engagement campaigns and programming to catalyze and support our online efforts for ProjectPengyou.org and continue to expand the goals of the 100,000 Strong Initiative. We conducted offline research by traveling to and meeting with schools and nonprofits across the U.S. to understand the needs and existing efforts of alumni engagement for China study programs. In China, we held about a dozen speaker series events engaging students and alumni, mostly from Beijing-based programs. This was the first in a three year grant from the Ford Foundation to support the 100,000 Strong Initiative. We met several times with organizing legend Marshall Ganz (based at Harvard University) and leaders of his China working group. In 2014 we plan to integrate Ganz's methodology into our grassroots community engagement and leadership efforts.

In 2011 & 2012, the China Medical Board commissioned a series of academic papers on the study of health and philanthropic developments in China. Golden Bridges was tasked to organize writers' workshops and management the disbursement of author honorariums.

Nonprofit Sector Research & Engagement (Expenses: \$2974)

In 2013, we continued to actively research behind the scenes and engage with practitioners in China's nonprofit sector. In June, we attended a Forum on Emerging Philanthropy which convened practitioners and philanthropists from developing countries around the world to share learnings and ideas.

This Forum was a first of its kind and was held in St. Petersburg Russia. Our president also gave numerous presentations on our signature research of the "Five Buckets of Philanthropy" to help audiences understand the landscape of giving and players in China's emerging nonprofit sector.

Continuing from previous years, Golden Bridges continues to serve a number of other nonprofits as an advisor or volunteer, including the Dandelion Project and School for migrant children and the China Youth Climate Action Network (CYCAN).
