US-China Events: Through support from the State Department and other funders, we provided strategic planning and support for events and programs that promote American study abroad in China and develop the next-generation of US-China bridge builders. A few events included: 1) The Fulbright Lecturer Program Fall Orientation in Beijing, China for a group of American Educators who received a Fulbright grant to teach in China. 2) Seminar on Promoting American Students to Study in China: Opportunities, Challenges and Solutions" co-organized with the US Embassy in Beijing and the Chinese Ministry of Education to encourage Americans to study in China. Please note that funding for the Seminar on Promoting American Students to Study in China was received in 2017

U.S.-China Strategic Services

Ripple Effect: In 2018, we provided strategic services and received grants, contributions and gifts to the Ripple Effect Initiative with the mission of reaching, connecting, bridging and expanding hearts and minds through the unique sounds, harmony and culture of American and Chinese folk music. The Ripple Effect is led by musicians Abigail Washburn and Wu Fei.

Committee of 100 : In 2018, our President provided strategic services to Committee of 100 including event management and other services. The Committee of 100 (C100) is a non-partisan leadership organization of extraordinary Chinese Americans in business, government, academia, and the arts. For nearly 30 years, C100 has been committed to a dual mission of promoting the full participation of Chinese Americans in all fields of American life, and encouraging constructive relations between the peoples and leaders of the U.S. and Greater China. Founded by master architect I.M. Pei and cellist Yo-Yo Ma, C100 members are pioneers in their respective fields, and serve as major influencers in American life.

PROJECT PENGYOU: In 2018, Project Pengyou programs continued through mostly volunteer engagement from our national leadership network: 1) U.S.-China Youth Leadership Training -- In 2018, we organized a convening for Project Pengyou Chapter Leaders to develop their U.S.-China leadership skills at Johns Hopkins University SAIS. 2. National Campaigns "Pengyou Day" and "PIFOCNY" -- Our annual Pengyou Day Campaign was held during the State Department's International Education Week which mobilized hundreds of American and Chinese educators and students to promote U.S.-China friendship & exchange. We also organized a "Pay it Forward on Chinese New Year (PIFOCNY)" Campaign, encouraging fellows and chapters to share their China knowledge to youth in elementary and middle schools, inspiring them to travel abroad, learn more about Chinese culture, and expand their horizons 3) Campus Chapters: Since 2014, Project Pengyou has launched nearly 80 campus chapters across 35 states. These chapters convene Chinese and Americans and create meaningful opportunities to deepen dialogue and mutual friendships on campus. 4) Projectpengyou.org -- We update and maintain an online resource hub with 6,000+ members, sharing listings of China-related jobs, events, and news.
