PROJECT PENGYOU: Project Pengyou is an initiative that supports friendship and good will between the U.S. and China through youth leadership development with Americans and Chinese, educational exchange, events, and nationwide campaigns. In 2019, Project Pengyou activity continued mostly through volunteer engagement from our national leadership network.  
1) National Pengyou Network: Since 2014, Project Pengyou launched nearly 80 campus chapters across 35 states to convene Chinese and American youth and create meaningful opportunities to deepen dialogue and mutual friendships. In 2019, communication and engagement continued through online Zoom meetings, social media platforms, and some offline events.  
2) National Campaign "Pengyou Day"- The annual Pengyou Day Campaign was held during the State Department's National Education Week, which mobilized hundreds of American and Chinese educators and students to promote U.S.-China friendship & exchange.  
3) Volunteer Leadership Council - In conjunction with winding down full-time staff for Project Pengyou, leaders from the National Pengyou Leadership Network created a volunteer leadership council to support the program's missions and coordinate community efforts through a new distributed leadership structure.

U.S.-China Strategic Services  
Ripple Effect: In 2019, we continued as a strategic partner for the Ripple Effect Initiative, with the mission of reaching, connecting, bridging, and expanding hearts and minds through the unique sounds, harmony, and culture of American and Chinese folk music. The Ripple Effect is led by award-winning musicians Abigail Washburn and Wu Fei.  
Committee of 100: In 2019, we supported volunteer coordination for the Committee of 100's Annual Conference and one other U.S.-China related event in September 2019.
